

This **LICENSE AGREEMENT** (the "License") is entered into on _____(Effective Date) between are **Nortel Networks, Inc.**, a corporation incorporated under the laws of Delaware, having offices at 2221 Lakeside Blvd, Richardson, Texas, 75082 (Nortel") and

_____, an _____ entity with offices at _____("Licensee").

For and in consideration of Licensee using the Academic Program Materials licensed hereunder in its training curriculum Nortel hereby licenses to Licensee the Academic Program Materials under the following terms and conditions:

License Grant

Nortel grants the Licensee a license to use the student materials and instructor materials created by Nortel for use in training curriculum ("Academic Program Materials"). For purposes of the preceding "use" means storing, loading, printing, displaying and delivering courses to students using the Academic Program Materials. Licensee must Use the Academic Program Materials in the form in which they are provided to Licensee by Nortel. On a case by case basis, based on Nortel written approval in advance, Licensee may adapt or integrate relevant portions of the content of the Academic Program Materials into courses or other Licensee owned content ("Adaptations"). Licensee will ensure that the delivery of course content will be spread over an academic term (i.e., one or more semesters, quarters, trimesters or summer session or equivalent, as applicable, in an academic year). For avoidance of doubt Licensee may not use the Academic Program materials for any purpose other than those expressly stated in this License. Licensee grants Nortel a non-exclusive, perpetual, worldwide license to use copy and distribute the Adaptations, including without limitation the incorporation of such Adaptations into Nortel's Academic Program Materials.

Ownership

All intellectual property rights to the Academic Program Materials are owned and copyrighted by Nortel or its third party suppliers. This License confers no title or ownership in the Academic Program Materials and is not a sale or transfer ownership of any rights in the Academic Program Materials. In that regard Nortel reserves all rights and licenses not expressly granted in this Agreement. Nortel's third party suppliers will be third party beneficiaries to this license with respect to any content in the Academic Program Materials that is licensed by Nortel from such third parties, and such third parties may assert their rights directly against Licensee in the event of any violation of the terms of this License.

Copies and Adaptations

Licensee may only make copies or Adaptations of the Academic Program Materials for the purpose of providing training materials to students, enrolled in courses offered by Licensee, by printing or posting the Academic Program materials on a secure website. Licensee may not provide students with access to Academic Program Materials in any form of electronic/downloadable format. You must reproduce all copyright notices in the original Academic Program Materials on all copies or Adaptations (with respect to portions derived from the Academic Program Materials).

Trademarks and Advertising

Nortel grants Licensee a non-exclusive, royalty free, limited right to use Nortel's name and logo and other trademarks as follows to offer and advertise the Academic Program Materials that the Licensee is authorized to use hereunder. All such use of Nortel's name, logo, and other trademarks will comply with Nortel's requirements. Such requirements shall be supplied to

Licensee upon execution of this agreement. Upon expiration or termination of this Agreement, Licensee shall cease all display, advertising and use of all such names, logos and other trademarks.

Licensee acknowledges and agrees that the Nortel names, logos and other trademarks from time to time permitted to be used by Licensee as provided in this Agreement and all good will associated with them are owned by and will remain the sole property of Nortel. Licensee agrees not to engage or acquiesce in or encourage any action inconsistent with or that contests or is otherwise prejudicial to such ownership by Nortel. Licensee agrees to identify Nortel's trademarks as being the property of Nortel or its Subsidiaries and Affiliates as applicable, and agrees that all use of such trademarks by Licensee will inure to the benefit of and be on behalf of Nortel and its Subsidiaries and Affiliates as applicable. Licensee will ensure that all such usage contains appropriate trademark attribution notices that identify Nortel and its Subsidiaries and Affiliates as applicable as the owner of such names, logos and trademarks.

Nortel may revoke the license granted in this Section if it deems that Licensee has breached any of its provisions.

Transfer

Licensee will not attempt to transfer or assign this License or any of the rights granted under it to any other party unless expressly agreed in writing in advance by Nortel.

Reporting

On a yearly basis, the licensee will provide Nortel with a report detailing in which locations the Academic Program Materials are used. This information should be e-mailed to Nortel at ntsa@nortel.com

Termination

Upon ninety (90) days written notice to Licensee, Nortel may terminate this License, for its convenience, both without obligation or liability of any nature. Upon termination, Licensee must immediately destroy all the Academic Program Materials together with all copies and Adaptations in any form.

Confidential Information—

“Confidential Information” means information disclosed by Nortel or Licensee to the other party that is designated at the time of disclosure as confidential (or like designation), is disclosed in circumstances of confidence or would be understood by Nortel and Licensee, exercising reasonable business judgment, to be confidential.

Each party will use reasonable care in holding the other's Confidential Information in confidence and not disclose it to anyone except the party's employees. However, a party may disclose the Confidential Information to third parties (e.g., subsidiaries, affiliates, auditors and subcontractors) who have a need to know for purposes of carrying out this License and have agreed in writing in advance to be bound by confidentiality terms substantially the same as those in this License.

Exceptions - Information is not protected if (a) a recipient can demonstrate through written documentation that it was already known; (b) it becomes known or generally available to the public (other than by act of the recipient) after its disclosure; (c) it is disclosed or made available in writing to the recipient by a third party having a bona fide right to do so and without similar

confidentiality obligations; (d) it is independently developed by recipient as demonstrated by its business records; or (e) it is required to be disclosed by subpoena or other process of law. The recipient will notify the disclosing party promptly of a subpoena or other process of law requiring disclosure.

Release of Information - Only with Nortel's prior written consent may Licensee (a) advertise, make public statements or publish information concerning this License or the relationship between Nortel and Licensee, or (b) use the name or trademark of Nortel with respect to any advertising, promotion, publicity, or representation that Licensee may make in connection with Licensee's business, services, or product lines. Nortel may withhold consent to such release if it is deemed by Nortel in its sole discretion not to be in Nortel's strategic business interests to give it.

"AS IS" Warranty

All of the Academic Program Materials provided and other information disclosed by Nortel hereunder is provided to you "as is". **NORTEL NETWORKS (AND ITS THIRD PARTY SUPPLIERS, IF ANY) EXPRESSLY DISCLAIM ALL WARRANTIES AND CONDITIONS, STATUTORY, EXPRESS OR IMPLIED, INCLUDING, WITHOUT LIMITATION, ANY WARRANTY OR CONDITION OF TITLE, MERCHANTABILITY, FITNESS OR SUITABILITY FOR ANY PARTICULAR PURPOSE (EVEN IF ON NOTICE OF SUCH PURPOSE), NON-INFRINGEMENT, CUSTOM OR USAGE IN THE TRADE WITH RESPECT TO THE INFORMATION CONTAINED IN THE ACADEMIC PROGRAM MATERIALS, AND THE USE OR OTHER EXPLOITATION OF THE SAME AND/OR THE RESULTS OR ITEMS RESULTING FROM SUCH USE..**

Damages

Except for claims arising from (a) Licensee's indemnification obligations under this License; and (b) either party's breach of confidentiality under the terms set out herein in that regard, neither party will be liable for any loss of profits, indirect, incidental, punitive or consequential damages under this License.

General

This License may not be modified or any right of a party waived, except by means of an amendment which expressly references this License and is duly executed by each of the parties.
